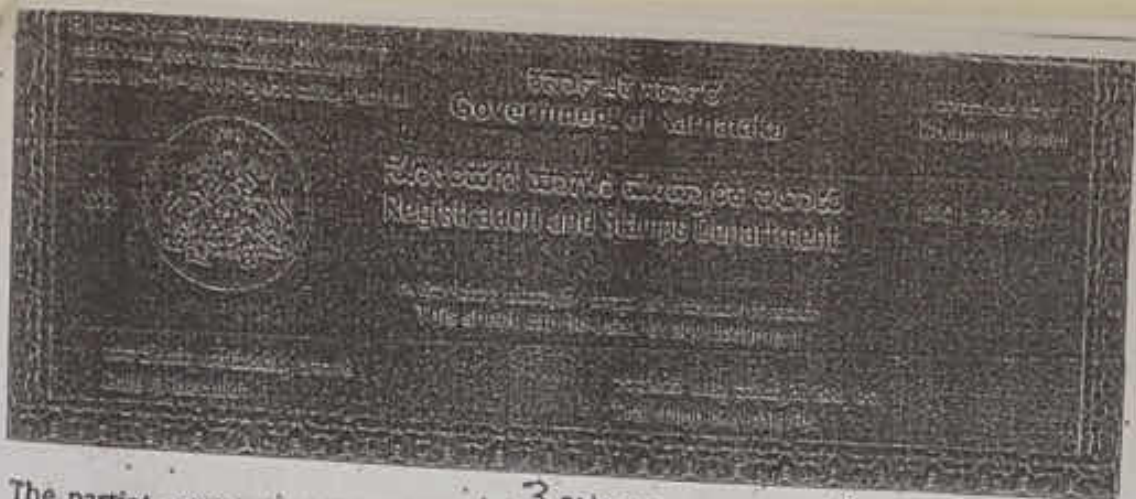

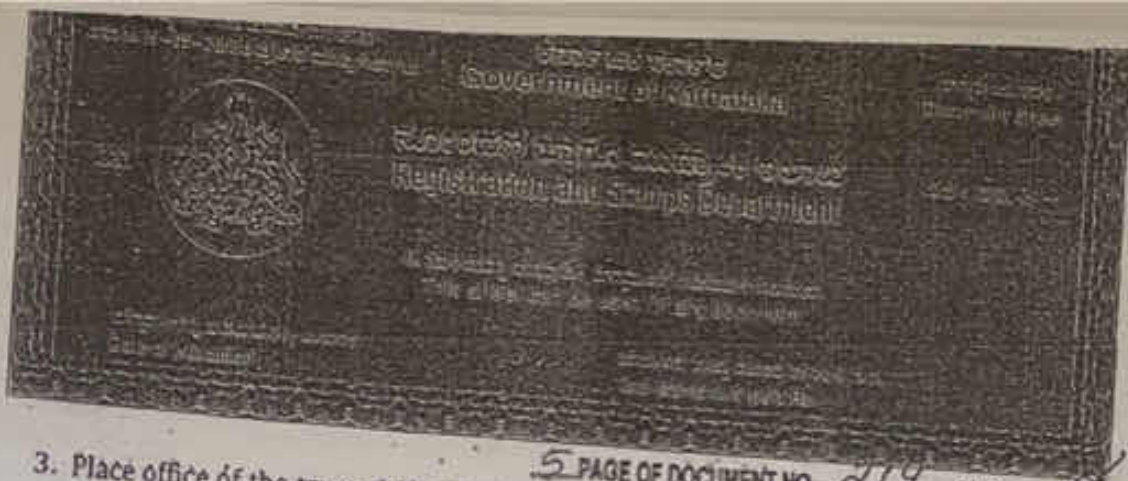

5. TRUST PROPERTY:-

The trust property shall consist of the initial trust fund Rs.5,000/- (Rupees Five Thousand Only) is contributed by the authors and all other amount of securities, properties movable and immovable which may be Contributed by the authors and other trustees acquired, possessed by trust and donations, gifts made by well wishers, philanthropists, grant, aid and contribution from State or Central Government or Organizations.

6. DEFINITION:-

- i. Trustee includes founders of the trust and also other trustees included in the trust from time to time.
- ii. BOARD OF TRUSTEES:- Means all the trustees including founders of the trust.

7. CEASATON OF TRUSTEE:

- i. Trustee may be terminated forthwith by the Board of trustees.
- ii. Any trustee may resign his/her trust ship of the trust by giving one month notice in writing to the managing trustee subject to approval of the Board of trustees, of his/her Intention to do so, and on the expiry of such notice she/he shall cease to be trustee.
- iii. A trustee to deemed to be disqualified if such trustee is:
  - a. Found to be of unsound mind by a court of competent jurisdiction.

b. Convicted for a criminal offence involving moral turpitude.

The Board of Trustees shall expel any trustee in case he/she does any act or pursue any conduct, i.e., either in contravention of the objects of the trust or in detrimental of credit or reputation to the trust. But no resolution for the expulsion of a trustee shall become effective, unless it has been passed at the Board meeting of the trust by votes of at least two third of the trustees in person at the meeting. Before expelling any trustee, Board of trustees shall give him an opportunity of being heard.

A register of trustees, patrons, donors, life members shall be maintained category wise with their names and addresses.

#### THE BOARD OF TRUSTEES:

- The board of trustees shall consist of not more than two trustees.
- The first board of trustees constituted after the declaration of the trust consists of all the two trustees of the trust.
- If the case of occurrence of any vacancy arising amongst the trustees by reason of death or incapacity or for any other cause, only legal heirs of the trustee shall be admitted as lifetime trustee.
- The Managing Trustee shall appoint or nominate his/her successors. In case there is no valid nomination of the successors to the present Managing Trustee, or the person so nominated refused or fails to accept or ceases to hold the post, for any reason, whatsoever the president shall be elected by the remaining members of the board of trustee.

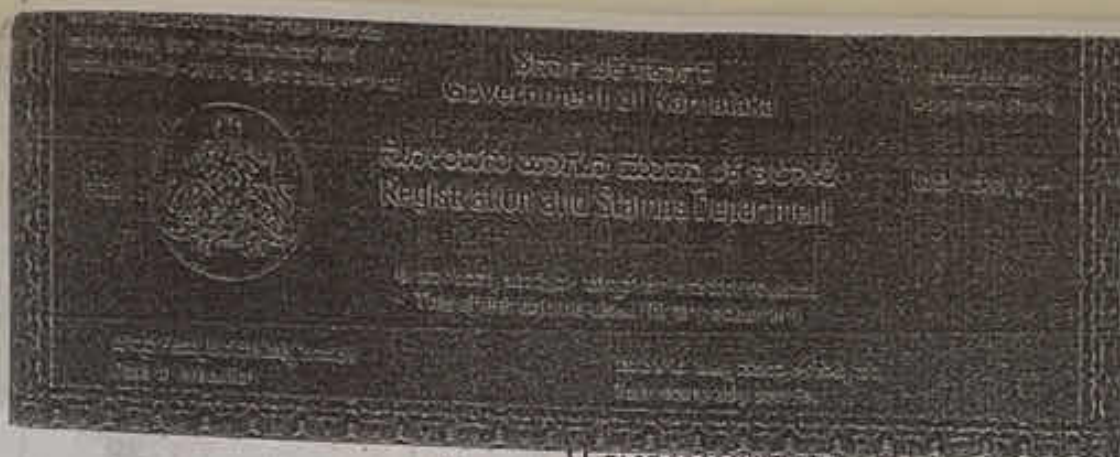

- e) Except lifetime trustees the co-opted trustee shall be in office for a period 3 years from the date of the first meeting after such nomination. And shall be removed whenever the lifetime trustees feels.
- f) The co-opted members of the trust are not eligible to hold the post of office bearer of the trust.

A trustee of the board of trustees shall be declared to have vacated his/her seat in the board.

- a) If he/she found to be lunatic or of un-sound mind
- b) If he/she is convicted of criminal offence
- c) If he/she is adjudged insolvent
- d) If he/she resigns his/her seat on the board or
- e) If he/she acquired any disqualification under these rules.

#### MEETING OF THE BOARD OF TRUSTEES:

- a) The board of trustees shall ordinarily meet once in three months or as often as may be necessary to conduct the business of the trust, such meeting shall be called ordinary meeting of the board of trustees.
- b) Special or emergent meeting of the board of trustee may also be convened by the managing trustee and in the absence of the Managing trustee the person who is working as acting resident or on the requisition of the three trustees.
- c) No business shall be transacted at the ordinary meeting of the board of trustees other than detailed in the agenda except with the permission of the Managing trustee of the meeting.

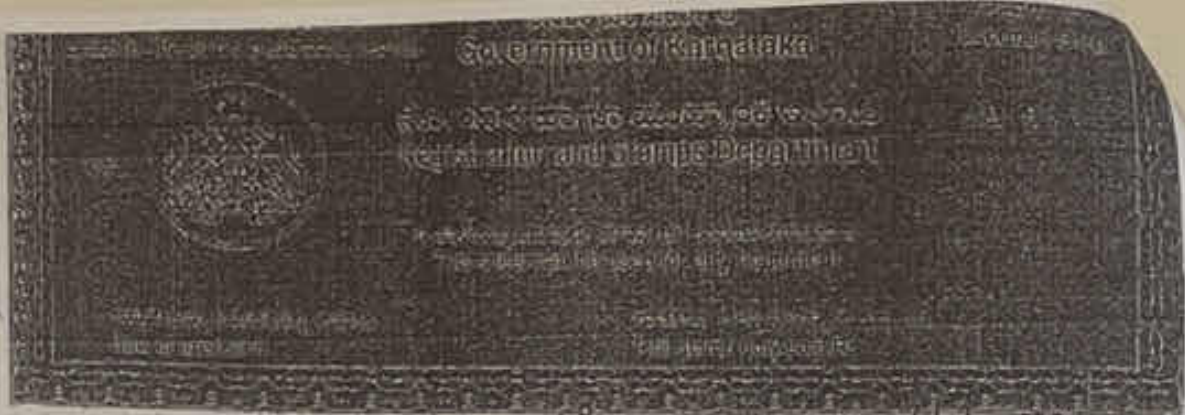

d) Three members shall be deemed to be the quorum for meeting of the board of Trustees. SR

If within 30 minutes of the time specified for the meeting of the board of the trustees called on quorum is formed the meeting shall stand adjourned and if for such adjourned meeting no quorum is formed the members who are present transact the business for which the meeting is called. But notice of the adjourned meeting shall be issued to all the members of the trustees well in time.

All the questions before a majority shall decide the board of trustees. The Managing trustee of the meeting shall have casting vote in the case of equality of votes.

The board of trustees shall cause the meeting to be duly recorded in the specifically kept for the purpose as early as possible after close of the meeting. If any member of the board of trustees desired to refer to the confirmed minutes of the board, shall be allowed to do so, at the office of the trust. During working hours on any office working day on his/her giving 3 days previous notice to the President.

The board of trustees may in additions to the power expressly conferred on it by there rules exercise all residuary powers and does all such acts and things expressly provided in these rules except those which are required to be exercised or by the trust at and ordinary or extraordinary meetings.

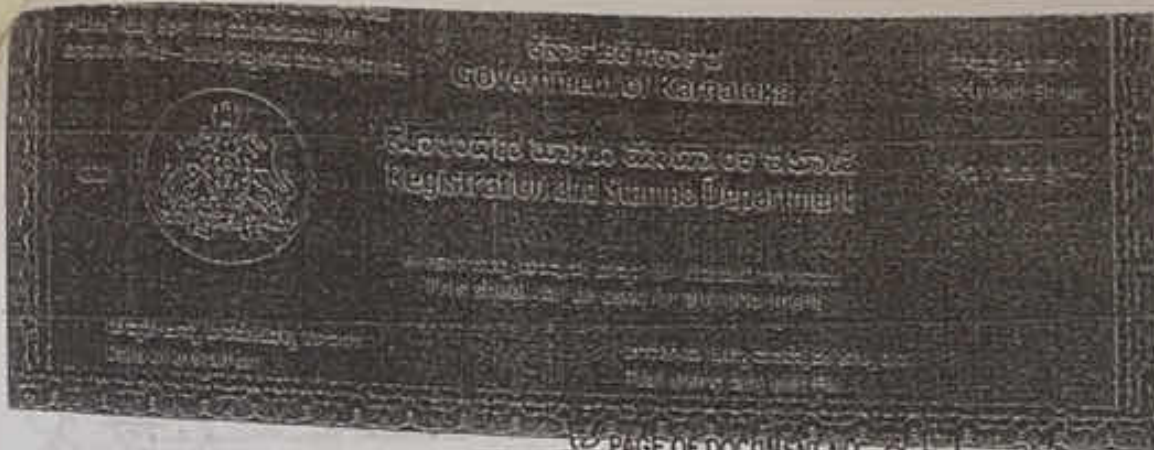

POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES:

SF

The board of trustees, shall without prejudice the general powers conferred on them in the trust deed, have powers:-

- To purchase or taken on lease or otherwise acquire any land with or without buildings thereon or to correct, construct, and build for alter any building or building thereon for the purpose of the trust and to pay for such purchase.
- To commence, institute, prosecute and all such actions and suits as the board of trustees may deem necessary and to compromise submit to arbitration the said actions and suit's as the board of trustees may in its discretion think fit.
- To engage the services of advocates, solicitors, and for other experts for the purposes of the trust, to pay, such remuneration as may be found necessary to authorize all any of them to respect the trust in all duly conducted course of law of before any arbitrator, or arbitrators, officers or officers or committees in connection with any measure affecting the interest welfare of all the institutions run by the trust.
- To incur and pay expenses necessary for carrying out of the aims and objects of the Trust.
- To collect and receive subscription, donations, contributions, payments and endowment for the purpose of the trust and to deposit money so collected and invest the surplus fund of the trust in scheduled banks, in the opinion of the trustees as may be deemed safe and desirable.
- To subscribe to become a member of and co-operate with any other institution, or associations, whether in corporate or not, whose, object are wholly or partly identical or similar to those of the trust and to

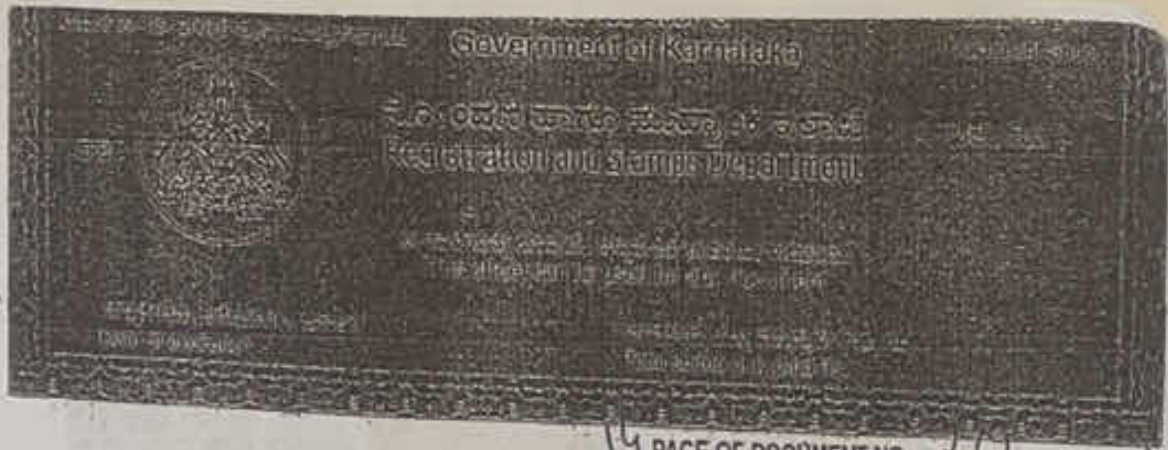

procure and communicate to any such institutions or association such information as may be likely to further the objects of the trust.

- i. To raise loans, securities, etc., on behalf of the trust.
- ii. To invest as and when it may deem necessary.
- iii. To open bank account in the name of the trust and account shall be operated by the Managing trustee by majority decision of lifetime trustees.

#### FUNCTION OF THE MANAGING TRUSTEE:

- a) The managing trustee shall be the chief controlling authority and shall preside over all meetings.
- b) The trustee if authorized by the managing trustee to act as managing trustee in the absence of the managing trustee and perform such functions as may be assigned to trustee by the managing trustee.
- c) In absence of the managing trustee, the trustees present shall elect a managing trustee form amongst themselves for that meeting purpose only.
- d) The Trustees generally assists the managing trustee.
- e) The managing trustee shall have a casting vote then members are equally decided on any matter in a meeting.
- f) The managing trustee shall supervise the trustee's work and shall from time to time issue such instructions as may be necessary for the due performance and holding of meeting if the trust and of any sub-committee of the trust.
- g) The managing trustee may delegate to the secretary some of his/her powers. The Managing trustee at his/her discretion can withdraw these powers at any time.
